REPORT to MLA E-Board 9 August 2016

National News

The Center for the Book in the Library of Congress is now organized in a new service area: National & International Outreach, specifically in the "national outreach" sector where it is aligned with Scholarly Programs and Educational Programs. The founding director, John Y. Cole, has been named Historian of the Library of Congress, and the Center for the Book welcomed a new director, Pamela Jackson, in June. Pam is focused on literacy, from basic skills through lifelong reading, as the driving vision of the CfB.

Local News

After four months of uncertainty, Mass Center for the Book learned on July 30th that it would have its funding restored to FY16 levels. We are now trying to play catch up on work from those many months of limbo.

We had small events with Rep Ellen Story in Amherst, Rep Stephen Kulik in Conway, and Rep Peter Kocot in Westhampton during May and June 2016. In each case, the legislators were there to celebrate Mass Book Award winners. These events have potential to grow in importance for outreach.

Currently ...

- 1. Fifteen librarians are now reading the long-listed books for this year's Mass Book Awards. We will announce their decisions in early October at the latest.
- 2. Letters About Literature will launch again next week.
- 3. We will call for nominations for the second annual Library of Congress/Massachusetts Literacy Award in the coming week to ten days.
- 4. We have been testing the new Commonwealth Events Calendar this summer and will host an intro and training webinar on 30 August (which we will record) to bring more libraries on board.
- 5. We are working on the following outreach initiatives:
 - a. National Book Festival September 24th in DC
 - b. Boston Book Festival October 15th in Copley Sq
 - c. Literary Walking Tour State House Loop 1 -- mid Sept launch
 - d. African American Writers of Massachusetts Literary Trail mid Sept launch
- 6. We are still researching the database options for a performance recommendation service for Mass librarians. Launch of that will be delayed.

Re: ALA Chapter Councilor Report from ALA Annual Conference, Orlando, FL, June 2016

Chapter Leaders Forum

This is a preconference day of idea sharing and special presentations, tailor-made for Chapter Leaders & Councilors from a broad group of chapters – about 35 participants. This is the third or fourth time I've participated, and find it a very worthwhile investment of time and energy.

Tennessee Library Assn presented on "State Associations & Cultural Legislation" – subtitled "Bathrooms, Bibles & Bias" so you get the gist of the presentation. (Presenter very rigorously researched ALA Code of Ethics for the presentation and distilled a lot of information and some background to establishing criteria/helping to determine when we as librarians are compelled by our ALA shared code to get involved in state/local issue and when we need to step back – "We distringuish betweenour personal convictions and professional duties..." etc.) Message is that some of our statewide advocacy efforts may be directed at values issues – i.e., not necessarily funding/legislative pieces. ALA is available for help and, in deference to local conditions and considerations, will NOT step in until/unless asked by local chapter. This protocol became a major source of discussion regarding another state/national issue which I'll share at our meeting.

Several people from Maryland Library Association and Trustee and United for Libraries presented on a unified voice for advocating... lot of potential for us in Massachusetts through the United for Libraries coalition. Let's discuss!

New Jersey "Makers Day" Fabulous success. Let's discuss at meeting!

Council Sessions and ALA updates: We had a lot of discussion at several sessions, and Council Forum I, II, and III, about gun violence and guns in libraries, etc. The Orlando shootings had just occurred within weeks of our conference and there was a definite pall over many sessions/proceedings. IN the end, the resolutions that were raised, revised, and reworked were finally referred to Committees whose charges had some bearing on the topic as individual state laws determine gun carrying laws. The main thrust of the resolution as it evolved became: Resolution on gun violvence affecting libraries, library workers,

and library patrons." The discussion pivoted quite a bit on the specifics of the resolution, some feeling that it was watered-down and insufficient and others feeling it was unenforceable and outside our ability to manage or implement. We spent many hours on this and learned a lot together.

Another highlight of council sessions and Chapter Relations Committee meetings and Chapters Forums is the relationship of the Chapters to ALA as a whole – how we can enhance communications, how we can strengthen our work, and how ALA interacts with Chapters. Incoming/new ALA President Julie Todaro is interested in this conversation and is establishing an ad hoc committee to push it further.

Libraries Transform! Let's discuss adopting as a state.

I have many handouts from Committees and sections and reports that I will bring Friday.

Treasurer's report

Association Manager's report

Tracey sees the fall as the time to gather information and finalize goals and then use that information finalize mission and vision statement by the end of 2016 or early 2017.

MLA Paralibrarian Section Report

August 10, 2016

The Paralibrarian Section held a transition and Conference recap meeting on June 6th at the Rowley Public Library. The Section Board welcomed Matthew Costanza, Head of Circulation at Medfield Library, as the new Conference Committee Liaison. Matthew was awarded the 2016 Outstanding Paralibrarian of the Year.

The Section Board and members' consensus was that the 2016 MLA Conference was a great success, with an excellent selection of programs and venue. The new video format for the BCDT competition was well received, and timing and scoring issues will be reconfigured for 2017 Conference.

The Career Development and PARA Review Board certified 13 paralibrarians with the PARA Certification at all levels. The PARA Certification has grown since its inception as a pilot program in 2006 to authorization as a Massachusetts Paralibrarian Certification program under the umbrella of the MBLC and MLA in 2013. We continue to receive requests for training and roundtable meetings throughout the state. Gerry Deyermond, Past Chair, will present a program on the MA and NH PARA Certification Programs at NELA Conference in October, partnering with Heather Shumway Rainier, Director of the Hookset Library, and Chair of the NH Paralibrarian Section.

The Section newsletter *FAST! FORWARD!* has been successfully launched under the direction of Section Co-Vice Chairs, AnnaMarie McGrath and Hermayne Gordon (Rowley Library). As well, the Section continues to send out its message via Twitter, Blog, Facebook, and the MLA website, and email.
